



- 1. Current (within one month) Criminal Records Check and Vulnerable Sector Check.
- 2. Current Alberta Class 1, 2 or 4 driver's license and current (within three months) driver's abstract.

Applicants must provide the following information within 180 days of application:

3. Certified Criminal Records Check (with fingerprints). The request provided to the RCMP must name the Town of Peace River as a third party to the application.
