**How to submit**

- Email **photographs** to [adietrich@peaceriver.ca](mailto:adietrich@peaceriver.ca) marked '2016 Calendar.'
- Only entries accompanied by a signed entry form will be accepted. Should a photograph include an image of any individual(s), only entries accompanied by a signed waiver from that individual(s) will be considered, if necessary a waiver can be obtained by contacting the Town office.
- Completed **entry forms** and **waivers** can be filled out and emailed to [adietrich@peaceriver.ca](mailto:adietrich@peaceriver.ca), faxed to the Town of Peace River marked 'Piece of the Peace', handed into the Town Office in an envelope marked 'Piece of the Peace' or mailed to the Town of Peace River (postmarked before October 23). When submitting photographs, please indicate the title on all photographs to match the entry form and waiver with the correct photograph.

**Term**

The closing date for entry is October 23, 2015 at 6pm. Entries will not be accepted after this time.

**Photographs**

- Photographs must be in digital format. Only emailed entries will be eligible. No print or film submissions will be accepted for entry. The photograph does not need to be taken with a digital camera; scans of negatives, transparencies, or photographic prints are acceptable and can be submitted electronically

- Photographs must be of a 4 Mega Pixel quality or higher, must be in JPEG or JPG format and must be at least 2,000 pixels wide.
- By entering the contest, the entrant represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.
- The photograph must not, in the sole and unfettered discretion of the Town, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.

### **Releases**

If the photograph contains any material or elements that are not owned by the entrant and/or which are subject to the rights of third parties, and/or if any persons appear in the photograph, the entrant is responsible for obtaining rights prior to submission of the photograph, any and all releases and consents necessary to permit the exhibition and use of the photograph in the manner set. If any person appearing in any photograph is under the age of majority in their province/territory of residence the signature of a parent or legal guardian is required.

By submitting photographs for this competition the entrant grants the Town of Peace River and its authorized agents irrevocable permission to use her/his name and submitted photographs for material relating to the promotion of the Town of Peace River. This extends beyond the Lower-West Peace project.

### **Contest Prizes**

Twelve winners will receive a free copy of the calendar and will have their photo featured on one-month page. One grand prize winner will be selected out of the 12 winners. In addition to the other prizes, the grand prize winner will also receive complimentary two-hour photography workshop an lesson (valued at \$400) from award winning editorial photographer, Adam Dietrich. The photo lesson cannot be exchanged for cash value.

### **Judging**

Winners will be selected by the Town's Communications Coordinator and will be notified the following week via email. We thank all those who submit but only the winning entrants will be contacted.
