THIS BYLAW AMENDS BYLAW 1479

WHEREAS on November 25<sup>th</sup>, 1991 the Council of the Municipality passed Bylaw 1479.

Bylaw 1479 regulates and controls the operation of the Mount Pleasant Cemetery of the Town of Peace River.

**1. Bylaw 1479 is amended by:**


