- A site plan or map detailing location of the special event and location of any barricades requested by the Applicant;
- Written description of any/all signs, banners to be erected in relation to the special event with installation locations; and
- Timing and duration of the proposed closure.

EVENT & CLOSUDE INFORMATION

The Applicant shall comply with all applicable laws, including Bylaws and Policies of the Town of Peace River.

The Applicant is to ensure that the participants provide right-of-way to emergency vehicles.

The Applicant is responsible for any resulting clean-up of the route or location at which the closure occurs.

Failure to comply with these conditions could result in the approval being withdrawn, denial of future applications and/or prosecution for breach of Town Bylaws.
