

## I. Overview

The Canadian aviation industry is facing a period of significant and ongoing change. This will have far reaching impacts on regional airports such as Peace River. This proposal develops a methodology for developing a practical business plan in changing and difficult times.

The sections following this one progress in the following manner:

- **Section II** explains the methodology and work plan of the project.
- The Project Team is reviewed in Section III.
- Budgeting and Time Lines are outlined in Section IV.
- Resumes and project lists are provided in **Appendix A.**

## II. Methodology and Work Plan

This section outlines the proposed methodology for the project. The project is comprised of a series of separate but related pieces of analysis which are then combined into a complete business plan. It is assumed that Rob Beynon would be in ongoing contact with the Steering Committee via telephone, fax and e-mail throughout the project. The first seven steps, A through G, are considered the Base Proposal. The remaining steps, H through M, are options which would add value to the project but may not be required by the Town of Peace River.

## A. Peace River Meetings

Purpose: To meet with the project steering committee and key community stakeholders.

Method: Rob Beynon will fly to Peace River and meet with the steering committee and stakeholders they recommend. This will be a one and a half or two day trip depending on connections.

## B. SWOT Analysis

Purpose: To determine Peace River Airport's Strengths, Weaknesses, Opportunities and Threats and to determine key trends with an impact on the site.

Method: The method for this will include the following:

- During the meeting with the steering committee a SWOT (strengths, weaknesses, opportunities, and threats) analysis will be discussed
- Key issues such as comparative strengths versus other sites will be analyzed subsequently
- Analysis of recent trends in aviation will be discussed
- A table showing Peace River's relative position will be prepared and supported by discussion

#### C. Scenario Identification and Projections

Purpose: To determine the range of operating scenarios that the site could face in the next decade and to prepare passenger and traffic projections to reflect those scenarios

Method: Based on current trends and historic traffic, a range of scenarios will be prepared. Using historic passenger and aircraft movement statistics, projections for the site will be generated in Excel and discussed based on the scenarios.

## D. Develop Operating Base Case

Purpose: To develop a base case operating budget projection model using current trends, expenses, and revenues.

Method: Steps to be integrated in developing this financial model include the following:

- The scenario projections will be used to drive the model
- Historic expenses and revenues will be shown and used as the starting point
- Five-year financial projections for each scenario will be produced
- The projected financial performance of the airport will be analyzed

Analysis will be completed in an Excel spreadsheet.

## E. Revenue and Expenses Recommendations

Purpose: To recommend changes to the expenses and revenues of the site which may improve its long-term performance.

#### Method:

- Examine fees and reasonable increases
- Consider options when current agreement with Canadian Regional Airlines ends
- Review airport operations compared with similar sites
- Consider alternative revenue generating options and steps required to achieve them
- Show the potential impact of these changes on the operating budget within the financial model developed in the step above

#### F. Review Draft Report

Purpose: To discuss the draft business plan with the steering committee.

Method: After preparing all the completed steps into a complete draft report and sending it to the Steering Committee, Rob Beynon will fly to Peace River to meet with the committee and to discuss changes to the report.

## G. Revise Report

Purpose: To complete the report and send final copies to the Town of Peace River.

Method: Based on the last meeting with the Steering Committee, the final report will be prepared and presented to the Town of Peace River. Five hard copies will be sent.

#### **OPTIONS**

#### H. Present Final Report

Purpose: To present the Final Report to stakeholders or Town Council.

Method: Rob Beynon would fly to Peace River after the report had been finalized and present its contents to groups chosen by the Steering Committee.

## I. Capital Assets Inspection

Purpose: To determine the state of the airport's capital assets, to understand when they will need replacement, and to estimate the anticipated replacement or modification cost.

Method: A qualified engineer would fly to Peace River and complete a visual inspection of all surface and building structures. A table would be prepared showing the condition of each structure, when it would need to be replaced or modified, and the anticipated cost.

## J. Capital Assets Reserve Fund Analysis

Purpose: To determine the Capital Assets Reserve Fund requirements for the airport.

Method: Note: A capital assets inspection (I) would have to be completed before this step could be undertaken. Based on the capital assets requirements identified in step I, an analysis on the capital assets reserve fund requirements would be completed. This analysis would identify how quickly

the funds are required, if the current reserves are adequate, and how much funding per year the fund requires for the next 10 years. The analysis will be developed in an Excel spreadsheet and integrated into the financial model.

## K. Develop Negotiating Strategy

Purpose: To develop a negotiating strategy with Canadian Regional for the period after the Town's contract with it has ended.

Method: The revised business plan would be a logical basis for negotiations with Canadian Regional after the existing contract ends. This negotiating strategy would provide recommendations on approaching Canadian Regional and the preparation of a new fees proposal for continued dealings with Canadian Regional.

## L. Power Point Presentation of Results

Purpose: To prepare a Power Point presentation for Town and airport staff to use when explaining the airport's business plan.

Method: Rob Beynon would prepare a Power Point presentation for Town staff to use. After consulting with the Steering Committee, this presentation would be completed and forwarded as an electronic file.

## M. ERS Impacts Analysis

Purpose: To analyze the financial impacts of potential revised Emergency Response Services (ERS) requirements on Peace River Airport.

Method: After reviewing the most recent Transport Canada drafts of the regulation, prepare a case for what the Town of Peace River would be expected to provide at the airport. Then analyze the operating and capital implications and integrate them into the financial model.

## III. Project Team

The proposed Project Team includes Rob Beynon with the support of a researcher. If the capital assets inspection is undertaken, it will be sub-contracted to a competent firm.

Rob Beynon, Beynon & Associates Inc., Project Manager. Mr. Beynon has more than ten years experience in port and airport operations analysis and research, and is the principal with Beynon and Associates Inc. Rob specializes in airport projects and he has been project manager for a wide variety of business planning, marketing and planning projects for airports in Canada, the U.S., and Australia. This has included working on a wide variety of passenger traffic surveying techniques including exist surveys, ticket pulls, travel agent surveys, and other forms of analysis.

Rob has worked on nine airport business plans in recent years, many of them with the Calgary Airport Authority subsidiary Airport Performance Group Ltd. This has included business plans for Grande Prairie, Prince Rupert, Williams Lake, Terrace, Cranbrook, Kamloops, Power River, and others. During the Williams Lake Airport Business Plan process, Rob assisted in the successful negotiation of fee increases with AirBC. He has completed planning studies for YVR Airport Services, Frontec and APG. Recent work includes ticket pulls and cargo studies at Prince George, Saskatoon, Regina, Thunder Bay, Kamloops and Penticton. Rob also just finished working with APG on the Grande Prairie Master Plan and a Business Plan for Prince Rupert Airport.

## IV. Budget and Time Lines

It is expected that the project will take approximately three months to complete. The completion date of the project will depend upon the start date.

The Beynon & Associates Team is proposing a maximum consulting budget for the base project of \$12,232 plus expenses and GST. Invoices will be sent on a monthly basis and expenses will be billed at cost. Terms of payment are net 30 days. The anticipated cost for each activity is shown below. Of the proposed options, none or all could be completed for the costs shown below.

#### Base Case

For the base project, two trips at an approximate cost of \$1,400 per trip are planned. Expenses will be billed at cost.

GST will be charged for consulting fees and expenses.

## **Options**

For option H a trip at an approximate cost of \$1,400 is planned. For option I a trip at an approximate cost of \$1,200 is planned.




